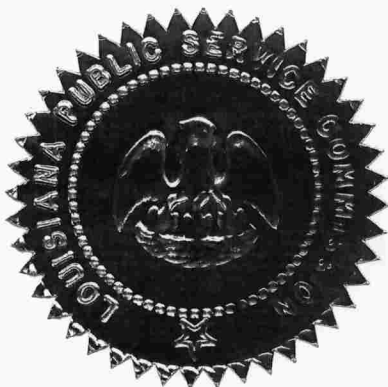
In re: Request for cancellation of LPSC No. 8252

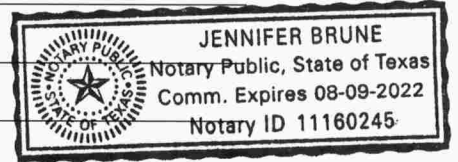
