Staff hereby proposes the following amendment to the General Order and requests specific comments no later than March 01, 2017.

Specifically, the General Order dated May 17, 2004, Ordering Paragraph 2 (E), is proposed to be amended as follows:

- (1) Any carrier whether domiciled in or outside of Louisiana, who is providing the intrastate transportation of household goods in Louisiana shall maintain a permanent establishment in Louisiana. A permanent establishment shall mean a fixed place of business through which the business of the carrier is wholly or partly carried on.
 - a. The permanent establishment shall be a particular building or physical location used by the carrier for the conduct of its business.
 - b.The carrier's use of this permanent establishment shall be more than temporary.
 - c.The permanent establishment may include a place of management, a branch, an office, or a terminal, but shall not be in a residence.
 - d.The permanent establishment shall be open for business and shall be staffed during regular business hours by one or more persons employed by the carrier on a permanent basis for the purpose of general management of the carrier's household goods moving business. Alternatively, the permanent establishment may be operated by an agent of the carrier provided that the agent has authority to conclude transportation contracts in the name of the carrier, and has habitually exercised that authority.
- (2) Any carrier domiciled outside of Louisiana and providing the intrastate transportation of household goods in Louisiana shall register the name, address, and telephone number of its Louisiana permanent establishment, with the Louisiana Secretary of State and the Louisiana Public Service Commission. Service of process with respect to all civil, criminal, or administrative proceedings brought before any court or administrative agency located in the state may be served on the carrier at its permanent establishment, by any means provided for in the applicable rules and procedure for providing service of process for that court or agency.
- (3) Should the carrier cease to maintain a permanent establishment in the state, its right to conduct business in the state shall be immediately suspended.

With the restriction that operations shall be restricted to the use of vacuum tank truck equipment and dump truck equipment only the applicant shall be restricted against movements in regular bulk tank vehicles without vacuum equipment.
- 2. Transportation of any and all materials and supplies used in connection with the drilling, maintaining, bringing in or cleaning out oil or gas wells, including, but not limited to, oilfield drilling muds, drilling mud chemicals and additives, acids, fresh water, salt water, drilling fluids and other liquid products demanded by the oil and gas and oilfield industry, including a complete vacuum truck service; from and to industrial plants and oil and gas field operations, statewide.
